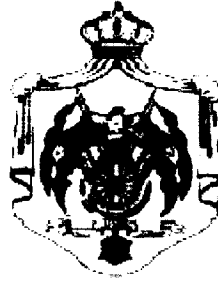

Requirements:

1. Original passport must be valid for at least (6) months and enclosed with this application.
2. As of September 1st, 2000, the fee of **(\$16.50)** for visa valid for 3 months and single entry. **OR** the fee of **(\$31.50)** for a visa valid for 6 months and Multiple entry. **(Money Order only)**
3. For business trips, a letter from employer stating the purpose of trip.
4. For diplomatic or official visas **(NO fee)**, a letter of request from your department.
5. Visa processing takes approximately (5) business days for U.S. Citizens.
6. **Very important:**
 - **Enclose a self-addressed prepaid (air bill) with a check payable to Federal Express or UPS, or DHL to return you passport(s).**
 - **No more than (2) passports per airbill.**

WE WILL NOT BE RESPONSIBLE FOR ANY LOSS THAT MAY OCCUR DURING PROCESSING.

Note:

- ➡ Visa fees are not refundable.
- ➡ Group visa can be issued for groups of (5) or more -- please fax to the Consulate your request for details.
- ➡ U.S. re-entry permits are not acceptable for travel to Jordan.
- ➡ Citizens of the United States, Mexico, South and Central America, and the countries of Western Europe could be issued visas upon arrival at the airport in Amman - Jordan.
